PROCEDURES Reporting Campus Incidents

A. Introduction

- 1. This document outlines the procedures for students, staff and faculty to follow when reporting incidents to the Campus Physical Development and Services (CPDS) and concerned departments.
- 2. The resolution of these procedures is to classify and deliver Notification of Incidents occurred involving staff, faculty, students, visitors, equipment, facilities or environment that are likely to give cause potential liability on Zayed University.

B. Procedures

- 1. The incident reporting system requirements apply to all incidents involving personal injury, illness or property/vehicle damage.
- 2. A life-threatening injury or illness must be reported immediately to the clinics, CPDS, and the local emergency response medical services.
- 3. The injured employee shall report injuries and illnesses to his or her supervisor. If the injured person is a student, the student should report the incident to the Student Affairs Department/Clinic and CPDS.
- 4. Upon notification of an injury or illness, Student Affairs/CPDS shall arrange for immediate treatment obtaining the clinic's help or ambulatory help from outside.
- 5. If the injury requires medical attention, arrangements should be made to transfer the injured person to a hospital emergency room and to have a doctor's report completed and sent to the Human Resources Department.
- 6. Upon notification of an occupational injury or illness, the department director with the assistance of an EHS committee member and CPDS shall complete an Incident Report and forward it to the Human Resources Department so that an insurance claim can be filed if necessary.
- 7. For reporting any general Environmental Health and Safety incidents, section 20 of the EHSMS Manual (<u>http://zuportal.zu.ac.ae/sites/CPDO/SiteAssets/Pages/Environment%2c%20Healt h%20and%20Safety/FormsDocuments/EHSMS_Rev-03.pdf</u>) is to be followed by the campus community.
