POLICY Grant-Funded Research Travel

1. Purpose

The purpose of this policy is to outline Zayed University's approach to supporting travel funded by research grants, as part of the university's effort to promote research and creative activity.

2. Scope of Application

This policy applies to any Zayed University employee funded by a research grant.

3. Policy

3.1 ZU supports its faculty in knowledge generation and sharing. ZU will therefore support appropriate travel for its faculty engaged in research in their academic disciplines or related to their pedagogical practice. Faculty will pursue relevant research opportunities for which they have requisite skills and will disseminate the results of their research to appropriate audiences. On occasion, as required by the nature of the research project, the university may also provide funding for research travel by non-faculty.

3.2 Parameters

- 3.2.1 Each financial year, faculty will have the opportunity to apply for different types of grants, based on funds available, through calls for proposals. This process will be managed by the Office of Research.
- 3.2.2 Grant applications may include travel that is directly related to the purposes of the grant and that is driven by needs that cannot be met at the university.
- 3.2.3 The Office of Research reserves the right to modify budgets in the awarding process, which may include reducing or removing travel expenses.
- 3.2.4 This policy does not apply to research travel by students. For student travel, see ACA-RES-105 Research Travel by Individual Student Policy.
