POLICY Internal Research Funding

1. Purpose

The purpose of this policy is to communicate Zayed University's commitment to internally fund research and other scholarly activities conducted by faculty and staff in order to contribute to global and regional knowledge, and achieve the institutional vision and mission.

2. Scope of Application

This policy applies to faculty and staff engaged in research at Zayed University.

4. Policy

- **4.1** The Zayed University ("University") internally funded research programs are implemented on a competitive basis. They are aligned with the priorities of the University's Research and Innovation Strategy to support research, innovation, and creative and scholarly activities within the need to promote a sustainable program of research, and will be used to develop criteria to allocate internal research funding.
- **4.2** Internally funded research programs will support regional, global, basic, and applied research to foster the development of the UAE's knowledge economy. Decisions on funding may prioritise, but will not be limited to, promoting research involving students and UAE Nationals in support of the strategic priorities of the University and the nation.

4.3 Internally Funded Research Grants

4.3.1 The Office of Research ("**OR**") will manage the internally funded grant programs at the University. At the designated time, OR will disseminate a

request for proposals which will outline the eligibility requirements and submission guidelines.

- **4.3.2** As these are competitive grants, submissions will be reviewed, and awards granted only when the research proposed is of high quality and meets the eligibility requirements. However, as internal research funding is limited, meeting the eligibility requirements does not guarantee a grant award.
- **4.3.3** After grants have been awarded, the principal investigator is responsible for managing the grant, following the appropriate research protocols, and completing the assigned reporting mechanisms.
- **4.3.4** Specific details for each of the internal grant programs are maintained on the OR website.
