POLICY Zayed University Student Council

1. Purpose

This policy outlines the guiding principles for the establishment and operation of the Zayed University Student Council in line with UAE Government regulations and Zayed University vision, mission, and values.

2. Scope of Application

This policy applies to all Zayed University employees and undergraduate students who are involved with the Zayed University Student Council.

3. Definitions

4. Policy

- **4.1** The Zayed University Student Council ("**Council**") serves as the officially recognized voice of the Zayed University ("**University**") undergraduate student body, acting as the link between the undergraduate students and the University administration, and being the official undergraduate student representatives involved with University governance whenever appropriate.
- **4.2** The Council will be established and will operate in accordance with UAE Cabinet Decision no. 334 of 2011 (and all subsequent revisions to this Decision and all related resolutions) regarding Higher Education Student Councils' By-Laws.

4.3 As representatives of the undergraduate student body, the members of the Council will uphold the highest standards of ethical behavior in all of their activities and interactions in line with the University's vision, mission, and values.

5. Guiding Principles

- **5.1** The Council will consist of 15 members including representatives of both campuses, all colleges, and male and female students.
- **5.2** Council membership will be for one (1) academic year from the time of the issuance of the official announcement of Council membership until the end of that academic year in line with the University Academic Calendar.
- **5.3** Five (5) Council members will be elected by undergraduate students, and ten (10) members will be chosen by a committee formed by the Provost and Chief Academic Officer ("**Provost**"), or designee, consisting of faculty members and Student Affairs representatives.

5.4 Eligibility

To be eligible for consideration for Council membership, a student must:

- a) Be an actively enrolled Zayed University undergraduate student.
- **b)** Be at least 18 years of age.
- c) Be in good academic standing, with a minimum CGPA of 2.8.
- d) Have no attendance or disciplinary issues.
- e) Not have been convicted of a felony or misdemeanor affecting honor or dishonesty.
- **5.5** The Council President and Vice-President will be duly elected by a majority decision of Council members at the Council's first meeting of the academic year.
 - **5.5.1** That first Council meeting to elect the President and Vice-President must be chaired by the oldest member of the Council.
- **5.6** The Council is expected to meet at least once a month. A majority of the Council members must be present for the meeting to be considered duly held.
 - **5.6.1** If the Council President is absent, the Vice-President must chair the meeting.
 - **5.6.2** The Council is expected to meet with the Assistant Provost for Student Affairs twice every Academic Year in addition to their monthly meetings.
- **5.7** The Council shall make its recommendations by majority vote. In case of a tie, the President (or Vice-President if the President is absent) shall have the casting vote.
 - **5.7.1** Council recommendations are not considered valid until appropriate approval has been obtained from the Director of the Student Leadership Department ("SLD").
- **5.8** The Council must not hold any conference, seminar, event, or meeting (other than the regular monthly meetings) without first obtaining appropriate approvals from SLD in accordance with University policy.

- **5.9** The Council will form sub-committees to implement the various tasks agreed by the Council. Each sub-committee will have its own President and Vice-President, and will submit reports to the Council as required.
 - **5.9.1** The Council must monitor the work of each sub-committee and obtain all required approvals and authorizations when necessary.
- **5.10** The Council will coordinate with other University student organizations and committees as appropriate.
- **5.11** The Council will coordinate with the student councils of other educational establishments as appropriate.
- **5.12** The Council will submit reports about its work, including those of the subcommittees, to SLD for review and guidance whenever necessary.
- **5.13** The Council will be allocated an annual budget by Student Affairs in accordance with University financial regulations.
 - **5.13.1** The Council is responsible for ensuring the transparent allocation of funds, as appropriate, to its sub-committees.
 - **5.13.2** The Council is responsible for maintaining accurate and transparent financial records of its operations, and for submitting those records to SLD as required.
- **5.14** The Council must obtain prior approval from the Director of SLD before receiving any rewards, gifts, or donations from any source other than the aforementioned budget allowance.
- **5.15** The Council is required to maintain accurate records of all its meetings and activities, to store them in a secure location, and to submit those records to SLD when required. The records must include but not be limited to:
 - a) Members' names.
 - **b)** Meeting minutes.
 - c) Financial records with supporting documentation.
 - d) Activities including coordination and interaction with other student groups.
 - e) Publications.
- **5.16** At the end of each academic year, the Council is required to hold an open meeting for all students and any other interested University community members, where the Council will brief the audience on the Council's work and achievements during that year.
- **5.17** The Council will publish an annual report at the end of each academic year, and this will be circulated to all students as a basis for the end-of-year meeting.
- **5.18** Any Council member who breaches any of the stipulations of this policy and/or the Undergraduate Student Code of Conduct will be subject to appropriate disciplinary action in accordance with University policy, which may lead to a permanent exclusion from the Council.

6. Student Council Goals

In accordance with Cabinet Decision no. 334 of 2011, the Council will endeavor to achieve certain goals including but not limited to the following:

- a) Introduce the University to all new students.
- **b)** Enhance collaboration and teamwork between University students, faculty, staff, and administration.
- c) Raise national, international, cultural, and intercultural awareness, and respect.
- d) Enhance ethical behavior and values.
- e) Raise intellectual, social, sporting, and artistic levels in the student body.
- **f)** Raise matters of general concern from the undergraduate student body to the University administration.
