POLICY Student Maternity Leave

1. Purpose

The purpose of this policy is to outline the support Zayed University offers to its female students who give birth in a given semester.

2. Scope of Application

This policy applies to the semester in which a female Zayed University student delivers her baby.

4. Policy

- **4.1** Zayed University ("**University**") is committed to providing support for its female students who give birth in a given semester.
- **4.2** The student concerned is allowed to suspend her registration for the semester in which the baby is expected to be born.
 - **4.2.1** A maternity suspension is not counted towards the total number of suspensions allowed by the University.
 - **4.2.2** However, in order for the student to maintain her Priority 1 status, she must re-register at the University after a period of suspension of less than one (1) year (MOE Federal HEI Financing System 2022, Student Categories).
 - **4.2.3** Accordingly, in order for the student to maintain her Priority 1 status, the maternity suspension must not be for the semester immediately before or after any other suspension.

ACA-REG-104 Policy

- **4.2.4** Students who lose their Priority 1 status are responsible for arranging their own funding for the remaining tuition fees until they complete their graduation requirements (MOE Federal HEI Financing System 2022, Financing Term).
- **4.3** If a student chooses to not utilize a semester maternity attendance suspension but decides to deliver her baby and return to complete the semester, she must stay within the 15% total semester absence requirement to receive credit for her courses.
