POLICY Graduate Student Attendance

1. Purpose

This policy describes the requirements and responsibilities of graduate students and faculty regarding class attendance for graduate courses at Zayed University.

2. Scope of Application

This policy applies to all graduate students attending on-campus and/or off-campus University classes. This policy does not apply to practicum/internships or thesis.

3. Definitions

4. Policy

Students are expected to attend all classes, labs, seminars, and examinations related to the courses in which they are registered. If they cannot attend class for any reason, they are responsible for following the guiding principles below in a timely manner.

5. Guiding Principles

- **5.1** The faculty will establish class attendance and record-keeping standards in the course syllabus based on departmental guidelines.
- **5.2** Students are not allowed to attend classes without being officially registered in the course.
- **5.3** Permission to make up work may be granted by faculty depending on the standards outlined in the course syllabus.
