# POLICY Student Conduct During Examinations

## 1. Purpose

The purpose of this policy is to set clear expectations for the conduct of Zayed University students during formal on-campus examinations.

## 2. Scope of Application

This policy applies to all Zayed University students taking formal on-campus examinations, such as placement or final exams.

## 3. Policy

Students are expected to abide by the Student Code of Academic Integrity and the Zayed University Honor Code for all of their academic work including examinations.

#### 3.1 Conduct Prior to and During the Examination

## a) Punctuality

Students are expected to be seated in the exam room and ready to start before the scheduled exam start time. Students who arrive late up to ten (10) minutes after the examination begins are allowed to take the examination; however, no additional time will be allowed at the end of the examination period for a student who arrived late.

#### b) Student Identification

The student must present their University ID card to be admitted to the examination room.

#### **3.2** Conduct During the Examination

The student must adhere to the rules and regulations set for the examination. Violation of the rules may result in discipline, including loss of the right to make up the examination and failure in the course, suspension or dismissal.

## 3.3 Request for a Make-up Examination

A student who misses an examination may request a make-up examination if they demonstrate a valid reason for their absence. The decision whether to provide the student with a make-up examination will be made by the Assistant Dean for Student Affairs in consultation with the instructor.
